Public Participation

Two members of the public present regarding flooding problems on Slater Street, Clay Cross. Councillor Wright and Councillor Mrs Reader agreed to pursue this issue with both Derbyshire County Council and North East Derbyshire District Council.

Police Consultation

PCSO Platts circulated crime figures for April. It was confirmed that there had been 7 violent crimes, 15 stealing crimes including 8 vehicle crimes and 2 drug offences. It was noted however that Clay Cross Safer Neighbourhood area had seen a reduction in crime against this time last year.

PC Bronwen Walton reported that PCSO Stephen Sweet was now training to become a full time Police Constable.

Councillor Wright raised the issue of reports regarding the use of drugs in the Clay Cross area. PCSO Platts requested that members of the public with intelligence/information should come forward.

County Councillor/District Councillor Attendance

Councillor Wright gave a County Councillor report. It was confirmed that the previous Council had signed contracts to close all adult care centres but the new Council are now trying to stop these closures - an officer will be visiting sites around the County over the next few weeks. It was also reported that the Extra Care facility currently under construction in Clay Cross is on course to be completed by January 2015, and that the work is being carried out by local contractors which is good for Clay Cross.

Councillor Morley reported that North East Derbyshire District Council Leader, Graham Baxter MBE has chosen Cabinet members for this year and Councillor Savidge is to carry on as the Chair of the Council for a further year and Councillor Mrs Reader will be the Vice Chair.
