County Councillor/District Councillor Matters

Councillor Wright reported that the Conservative administration at Derbyshire County Council are pressing ahead with the 'Better Care, Closer to Home' initiative by closing down care homes/community hospitals. It was confirmed that the INEOS application to drill below ground off Bramley Moor Lane, Marsh Lane, Eckington will be discussed at a Planning Committee meeting to be held on Monday, 29 January 2018. Concern was expressed that the County Council have withdrawn its annual grant of £41,769 to the Derbyshire Unemployed Workers Centres, the decision comes into effect on 31 March 2018.

1. ***(a) Parish Administration Wages budget is increased to £73,000 to make provision for the increase in the National Living Wage and (b) all wages are increased by a flat rate of 33p per hour from 1 April 2018***
2. ***the Cemetery Lodge rent is increased by £2.74 to £80 per week from 4 April 2018***
3. ***the allotment rents are increased by £5 to £20 per plot from 1 September 2018 and that this price is held for the next 5 (FIVE) years***
4. ***any Charity/community events to be held at the Social Centre are put before the Parish Council for approval***
5. ***all other 2018/19 budgets, expenditure and income are accepted and approved***
6. ***Clay Cross Parish Council funding for 2018/19 is increased by 1.8% giving a total of £215,505.08; a Precept of £198,752.44 plus Grant funding of £16,753.14 with the Parish Council making a contribution of £1,180.42 from balances***
7. ***the monthly statements for October 2017, November 2017 and December 2017 be accepted***
8. ***the expenditure and income against budget report for October 2017, November 2017 and December 2017 is accepted***
