Public Participation

Two members of the public in attendance to report problems with teenagers on Bevan Road between 11pm and 1am most evenings. Police officers present confirmed they would start patrolling this area and move the problem on.

Ann Tyler, Deputy Head and colleague from Sharely Park Community Primary School were present regarding the school plans for a community garden. Parish Clerk reported that this matter will be raised under Reports from Representatives on Outside Bodies later on in the Agenda.

Two members of the public present regarding ongoing problems at Denham Street, Clay Cross. Councillor Wright reported that he has made enquiries following the concerns raised at a previous Parish Council meeting but as the road is classed as an unadopted/private street, County Council Highways have denied responsibility and so have both water authorities – Severn Trent and Yorkshire Water.

Police Consultation

PC Walton reported that there were 34 crimes from 1 June 2013 to midnight, 30 June 2013: 8 of violence against a person, 17 of stealing, 5 of criminal damage including arson and 4 drug offences.

Other matters reported:

- on the 4 June 2013 officers carried out a speed watch on Holmgate Road. 79 cars were checked for their speed and stopped, 8 of these for speeding in excess of 35mph

- PC Emily Sunderland had now joined the Clay Cross Safer Neighbourhood Team
- PCSO Platts is representing Clay Cross Safer Neighbourhood Teams Twitter account, any tweeters can follow @ClayCrossSNT for updates and crime prevention advice

Councillor Wright requested information regarding an elderly person in the Market Street area being involved in a forced entry into their property and threatened with violence, and that he was concerned for the safety of all the residents nearby. PC Walton reported that the Clay Cross Safer Neighbourhood Team have carried out patrols in this area to ensure that a Police presence is being seen.

received from School Deputy Head, Anne Tyler confirming that following their initial refusal, Awards for All have now granted £10,000 toward the cost of the project and a company is ready to start the work in September, approximately 13 September 2013.
