Public Participation

Police Consultation

Parish Clerk circulated crime figures for the months of late December and January. All Councillors welcomed the new report which contains more information on crime figures and local Safer Neighbourhood matters.

Parish Clerk reported that Derbyshire County Council have confirmed that they will take over Civil Parking Enforcement powers from Derbyshire Constabulary with effect 19 February 2009.

Councillor J M Holmes and Councillor B Wright restated the following declaration regarding their dual role on Planning matters. During this Parish Council meeting on Planning matters, we shall not be expressing a conclusive view on the applications and we give a declaration that we will be formally reconsidering the matters when we are in receipt of all the information at the District Council Planning Committee.

Planning Application 09/00061/FL Change of use of land (retrospectively) from residential to residential and storage of a helicopter (within domestic cartilage) at Hollis Farm, Holmgate Road, Chesterfield for Mr Karl Haynes.

The Parish Council request that this application goes to full planning committee meeting and is not dealt with by delegated decision. A site visit prior to a full Planning committee meeting is also requested. The Parish Council are concerned that, from the plans provided with the application, the landing/take off area for the helicopter appears to be very near to public footpath no 17.

Planning Application 09/00135/OL Application for outline planning permission for the erection of two dwellings (revised scheme to NED/08/01147/OL) at 6 Florence Road, Clay Cross for Mrs Annette Bradley. **The Parish Council have a number of concerns with regard to this proposed development. The main two being that access to the proposed development is inadequate and that the proposed development is too big for the existing area.**

Conditional Approval of Planning Application 08/01068/FL Retention of agricultural building for livestock and storage of tractors and farm implements at Hollis Farm, Holmgate Road, Clay Cross for Mr Karl Haynes. **The Parish Council note this conditional approval of planning application.**

Conditional Approval of Planning Application 08/01163/TPO Application to prune Ash Tree T7 covered by North East Derbyshire District Council TPO 108 at 9 Colliers Way, Clay Cross for Mr Paul Wheeler. **The Parish Council note this conditional approval of planning application.**

Conditional Approval of Planning Application 08/01176/FL Application for single storey extension and two storey rear extension of 80 Ashover Road, Old Tupton for Mr Ian Whiteside. **The Parish Council note this conditional approval of planning application.**

Conditional Approval of Planning Application 08/01122/FL Erection of an agricultural building for free range hens (Major Development) (affection a Public Right of Way) (Amended Title) (Amended Plans) at Stretton Hall Farm, Newmarket Lane, Clay Cross for Mr Mark Meredith. **The Parish Council note this conditional approval of planning application. Councillor D Skinner stated his disappointment that this planning application had been allowed as concerns were raised with regard to the size of building and environmental issues.**

Withdrawal of Planning Application 08/01147/OL Outline application for the development of four 3-bed dwellings (all matter reserved) at 6 Florence Road, Clay Cross for Mrs Annette Bradley. **The Parish Council note this withdrawal of planning application.**
