Minutes of Clay Cross Parish Council meeting held in the Clay Cross Parish Council office on Tuesday 26 January 2010 at 7.00pm.

Public Participation

Heather Wesson is a Health Development Worker with Derbyshire PCT. Heather explained that she works throughout North East Derbyshire but that Clay Cross is one of her main areas. The Development Workers work in partnership with other organisations, community groups and members of the public and their aim is to develop community based projects. They also organise awareness events in food, alcohol abuse and community allotments/gardens and can research possible funding sources. Heather emphasised that she is happy to help at events arranged by others and Councillor Mansbridge advised her of the Marketing the Markets initiative at which joint working would be beneficial. Councillor Wright asked whether Heather would be able to assist with allotment constitutional issues which she confirmed she could research. Councillor Skinner stated the benefits of involvement in horticulture/allotments for those with learning difficulties and that he would pass on Heathers details to his colleague.

Police Matters

The Parish Update and crime figures for January 2010 were circulated. Councillor Wright reported that Anti Social Behaviour in areas of Danesmoor particularly Penncroft Lane and Cemetery Road seemed to be worsening and was unacceptable. Councillor Holmes advised that there had also been problems with youths at the St Barnabas Centre stealing cups and water and playing dare with the traffic on Pilsley Road. Councillor Riggott stated that the police are working hard in this respect but that its not easy to deal with. Councillor Skinner raised the issue of traffic congestion on Market Street and the junction of Holmgate Road and High Street due to motorists parking on double yellow lines while using the bank cash tills. This is causing a dangerous situation which needs resolving. **It was agreed that the Administrative Assistant would email Inspector Waterfall about both these issues.**

County Councillor/District Councillor Attendance

Councillor Riggott reported the recent protest outside Sharley Park Community School because of the heavy traffic on Pilsley Road. Councillor Riggott would like to see a Pelican Crossing installed. **It was agreed that the Administrative Assistant would contact Derbyshire County Council re progressing this.**

Councillor Mansbridge stated that parking outside the police station on Pilsley Road was also causing a danger. Councillor Riggott advised that there is a meeting arranged with Inspector Waterfall to discuss how to resolve this.

Councillor Riggott reported that the Town Centre Development would be commencing imminently and circulated a Press Release from North East Derbyshire District Council. There is to be an open day on Friday 26 February 2010 in the Social Centre where the detailed regeneration plans can be viewed and further information obtained about the Clay Cross public art project.

Councillor Skinner raised concerns about Rykneld Homes choice based lettings system. **It was agreed that the Administrative Assistant would seek the input of Rykneld Homes to the issues raised.**
