Councillor Wright reported on matters regarding primary school provision for Clay Cross. Councillor Alex Dale has confirmed that the catchment area for the Parish will be the new school on The Avenue site at Wingerworth; there are no plans to use the former Danesmoor Infant School/site and Sharley Park Community Primary School cannot be extended further. The meeting felt that there was plenty of alternative sites/land available in Clay Cross to build a new school. It was AGREED that a letter from the Parish Council is sent to Councillor Dale requesting an explanation/reason why a new Primary School is not being considered for Clay Cross.

Councillor Wright confirmed that Her Majesty's Inspectorate of Constabulary last week issued a damning report stating that Derbyshire Police "urgently" need to improve the way they look after vulnerable children. It was further reported new homes as part of the Pine View regeneration will commence in January 2022.
