Parish Clerk reported that due to other commitments, Councillor Kevin Gillott and Councillor Charlotte Cupit were both unable to attend the meeting.

Councillor Morley reported that another District Councillor has resigned from the Conversative Party and gone Independent.

Councillor Wright reported that after campaigning for some time, work will start in the next few weeks to deal with the issues on Brassington Street regarding the trees and repairs to the pavements etc.

Work In Progress

Further to minute no **3229/22** regarding proposal to redraw the Parish boundary. Parish Clerk reported that Councillor Kevin Gillott has had several conversations with Donna Jawad from Democratic Services at the District Council about the process for changing Parish boundaries so that the properties on Bloomery Way can be transferred from Pilsley to Clay Cross. As expected, it is proving to be complicated nut to crack, partly because it involves two parliamentary constituencies. Advice from the Boundary Commission is being sought as to how best to bring about the changes and what process needs to be followed.

<u>Resolved That:</u> this area is cut back by 1 metre from the boundary fence of 12 Holmgate Road and that the Parish Clerk ascertains if this area is included in the Grounds Maintenance Contributions undertaken by the District Council

Work In Progress

Further to minute no **3250/22(b)** regarding Parish Allotment Site Visits. Councillor Rouse reported that a site visit had been carried out on Sunday, 25 September 2022 with the Parish Clerk and two Tenants at Valley Road allotments. During the visit it was noted that most of the site was being gardened in accordance with the Allotment Terms & Conditions however, two plots are not being gardened in a proper manner so the Parish Clerk will address this with the Tenants. It was further noted that three plots had not been gardened for some time and were overgrown; one plot was being used for burning household waste.

Further to minute no **3235/22(b)** regarding Meadow Farm Fishing Pond. Parish Clerk read out an update email received from Clay Cross Angling Association Secretary, which the meeting noted. It was re-iterated that a meeting will be arranged between all stakeholders (Kenning Park Community Group, Clay Cross Angling Association, Kenning Park Forest School & Clay Cross Parish Council) to discuss the actions to be taken going forward.

Further to minute no **3235/22(d)** regarding Coupe Lane Flood Investigation & Riber Crescent Watercourse Relocation Proposal. Parish Clerk reported that an update had been received from John Vilas, County Council Flood Risk Management confirming that after completing a topographic survey of the path of the potential watercourse relocation through the horse pasture and exploring possible design options, it was determined that an open channel would be excessively deep and would not be feasible due to cost and the extent of the area that would have to be excavated. As this option is no longer feasible there should be no effect on the pasture or horses. Alternative options are still being explored to achieve a suitable outfall below the existing culvert system and he will keep us informed of these options as they are developed.

Councillor Mrs Jones reported that she had not been able to make any inroads with the Police regarding their attendance at a Parish Council meeting to discuss anti-social behaviour concerns in Clay Cross.

Further to minute no **3252/22(a)** regarding a triangulation meeting of the Climate Change Working Group. Councillor Mrs Reader reported that a meeting was held on the 1 August 2022 but due to unforeseen circumstances, no Minutes of this meeting had been produced. It was felt that another meeting of the Group needed to be held so the Work Programme can again be discussed in detail to produce a report of recommendations for presentation to the Parish Council including the Working Group being dissolved. *Councillor Mrs Reader to provide Parish Clerk with some dates/times so that a meeting can be arranged.*

3267/22 Cemetery Matters

Parish Clerk reported that following consultation with Councillor Wright, consent has been given to the Commonwealth War Graves Commission (CWGC) to install a Gallipoli Marker at the head of the existing grave of casualty Joseph Clark of Sherwood Foresters. It was noted that the CWGC will meet all the costs and will be responsible for the graves future maintenance.

Councillor Wright reported that an email has been received from the family via Mark Fletcher MP. *It was agreed that the Parish Clerk replies to the Caseworker to Mark Fletcher MP and re-iterate that the Parish Council would not allow cremated remains to be buried in a burial plot first; a burial plot must first be used for a burial before any cremated remains can be added*
