## **County Councillor/District Councillor Matters**

Councillor Cupit was in attendance and reported the following:

- 2 (TWO) trees on the A61/High Street have been removed in the vicinity of the Methodist Church after being deemed dangerous
- funding has been made available to support community events to celebrate the King's Coronation in May
- a banking 'hub' has been confirmed for Clay Cross. They are a shared banking space on the high street. They will offer a counter service, where customers of all major banks (and building societies) can carry out regular cash transactions, Monday to Friday. A suitable town centre venue is now being sourced
- Derbyshire County Council have set their budget for the year ahead and agreed a Council Tax rise of 3.75%

Councillor Ms Rouse confirmed that the recent vandalism at the Forest School was reported to the Police and the culprits have now been dealt with.

Following a recent inspection, one tree in the Park has been identified as dangerous with a further three trees being found to be starting with Ash Die Back. <u>Resolved That:</u> following a vote of 4 in favour and 2 against (Councillor Morley and Councillor A Rouse), D&P Garden Services undertake work to remove three trees with the start of Ash Die Back and one tree with crown damage at a cost of £1,500 no VAT; Parish Council and the Community Group to share cost 50/50.

The Parish Council again heard reports from the Councillors who have visited the site and from the Parish Council Tree Warden. Communication was also discussed from residents adjacent to the small copse who support the Parish Council's view that the trees should remain. <u>Resolved That:</u> the Parish Council do not give permission for trees to be removed and will not share any costs.

Councillor Morley reiterated that the Chapel is in poor condition and a programme of works need to be considered; the first phase being the replacement of the windows but care needs to be taken with the work as the building is Grade II listed.

It was reported that a meeting will be taking place with the District Council to discuss the Cemetery Ground Maintenance Agreement, especially the number of cuts and that conversations are ongoing with the Revenues Section regarding the payment of Business Rates for the the Cemetery & Premises
