### **Public Participation**

Two members of the public were present and spoke about concerns regarding town centre traffic/pedestrian safety. Several items were queried and clarified satisfactorily by the Officers in attendance from Clay Cross SNT.

Ten members of the public were present and spoke about concerns regarding any proposal to sell the open space at North Street, Holmgate including the disposal of the allotment site.

Richard Trinder (and Tony Sanghera) spoke about the role of the Banking Hub in the community, to keep access to cash as per the new legislation and to protect those in society who are less digitally able. Richard explained that people can do all their banking in the Hub no matter who they bank with, except for Nationwide and some of the online only banks. It was explained that the major banks would be sending in staff on a rota basis to see their clients without appointments to help with specific needs such as mortgages, loans etc. The opening hours of the Hub, which will be situated in the former Fulton Foods unit near Clay Cross Medical Centre will be Monday to Friday, 9AM – 5PM but if the demand needed longer hours, this would be considered along with a free to use ATM. The provision date for the Hub to be operational is Friday, 17 November 2023 but this could change depending on how quickly the necessary building work is carried out.

### **County Councillor/District Councillor Matters**

Councillor Gillott spoke about a consultation regarding double yellow lines on Pilsley Road and the Fairways in Danesmoor, and Councillor Cupit spoke about a similar consultation at the junction of Florence Road near to Matt Smith Vets; residents in the areas concerned have been informed at this informal stage.

Regarding the County Council Budget. It was noted that Cabinet papers have been sent out stating the Council may have an overspend of £46M and what this will mean for local services is unknown, but the Council is not broke yet. It was confirmed that monies earmarked for the Clay Cross Town Deal will not be affected as these are essential services.

Consideration was given to a request from a resident for trees to be cut back/trimmed along the boundary of the Cemetery/Wheatcroft Close which are affecting their satellite reception. Following advice from the District Council, it was confirmed that poor reception for satellite/Sky TV is not a reason to reduce neighbouring trees; the dish can be adjusted skywards to allow for any permanent obstructions and the resident should consult their installer/provider to have the dish adjusted or raised. **Noted.**
