(b) to consider the urgent motion put forward following the recent flooding in the Clay Lane/Windermere Road area:

Council notes with great concern the flooding experienced by residents of properties on Clay Lane and express its sympathy and support to those affected. Council shares the view that the granting of planning permission by the then North East Derbyshire District Council Planning Committee in December 2020, despite being warned of the flooding risks that would result from building on the floodplain, exacerbated the extent of the flooding and resulted in more properties being affected.

#### Resolution:

The Parish Council write to North East Derbyshire District Council, Derbyshire County Council and the Environment Agency calling upon them to:

- 1. support the residents in dealing with the immediate consequences of the flooding, and
- 2. call for flood prevention measures to be installed to ensure that this community never suffers from flooding again;
- 3. and also writes to the Member of Parliament for North East Derbyshire asking that the secure government funding to support the residents during this time and to fund future flood prevention work

### 3400/23 Kenning Park Matters

Councillor Mansbridge reported on the site visit held on the 5 July 2023 where the Community Orchard proposal was discussed with representatives from Climate Action North East Derbyshire (Minute 3195/22). The area identified for use would be a small development of fruit trees on the Pond side of the Park along the footpath leading to Holmgate Primary School & Nursery; the trees would ideally need planting from September – March.

Comments: Councillor Mansbridge to bring back funding and maintenance details for the Orchard project to the next full Parish Council meeting.

# 3401/23 Street Scene Matters

Councillor Mansbridge reported on the 'Community Fun Day' that will be taking place on Tuesday, 31 October 2023 at the wooded area off Watercress Lane adjacent to Parish Council owned land at Bevan Road, Danesmoor (Minute 3361/23); he would be in attendance along with the Tesco Clay Cross Community Champion, Kenning Park Forest School and representatives from Rykneld Homes.

Councillor Morley reported that funding had been received from Derbyshire County Council to replace 4 x bus shelters on the Cemetery Road/Springvale Road section of the 51 bus route; once the work has been completed, the Parish Council would continue to be responsible for their maintenance.
