Parliamentary Election

for

NORTH EAST DERBYSHIRE

1. An Election is to be held of One Member of Parliament for North East Derbyshire.
2. Forms of nomination for the Parliamentary Election may be obtained at District Council Offices, 2013 Mill Lane, Wingerworth, Chesterfield, Derbyshire, S42 6NG from the Acting Returning Officer who will, at the request of an elector for any electoral area prepare a nomination paper for signature.
3. Nomination papers must be delivered by appointment only to the Acting Returning Officer, District Council Offices, 2013 Mill Lane, Wingerworth, Chesterfield, Derbyshire, S42 6NG on any day after the date of this notice between the hours of 10am and 4pm but no later than 4pm on Friday, 7th June 2024. Please contact 01246 217058 to make an appointment.
4. The required deposit of £500 may be made either by the deposit of any legal tender including by debit or credit card or the electronic transfer of funds.
5. If any election is contested the poll will take place on Thursday, 4th July 2024.
6. Applications to register to vote must reach the Electoral Registration Officer by 12 midnight on Tuesday 18 June 2024. Applications can be made online: <https://www.gov.uk/register-to-vote>
7. Applications, amendments or cancellations of postal votes and amendments or cancellations of proxy votes must reach the Electoral Registration Officer at District Council Offices, 2013 Mill Lane, Wingerworth, Chesterfield, Derbyshire, S42 6NG by 5pm on Wednesday, 19th June 2024. 8. New applications to vote by proxy at this election must reach the Electoral Registration Officer at District Council Offices, 2013 Mill Lane, Wingerworth, Chesterfield, Derbyshire, S42 6NG by 5pm on Wednesday, 26th June 2024. Applications can be made online: <https://www.gov.uk/apply-proxy-vote>
9. Applications for a Voter Authority Certificate or an Anonymous Elector's Document valid for this election must reach the Electoral Registration Officer by 5pm on Wednesday 24 April 2024. 10. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at District Council Offices, 2013 Mill Lane, Wingerworth, Chesterfield, Derbyshire, S42 6NG by 5pm on Thursday, 4th July 2024. The physical incapacity must have occurred after 5pm on Wednesday, 26th June 2024. To apply on the grounds of work/service, the person must have become aware that they cannot go to the polling station in person after 5pm on Wednesday, 26th June 2024.
