3482/24 Kenning Park Matters

With regard to the request received from Clay Cross Angling Association for permission to install 2 (TWO) new 8ft x 8ft recycled fishing pegs at the outlet (West) end of Meadow Farm Fishing Pond (Minute 3454/24).
